

Job Title: Residential Night Care Worker

PURPOSE OF JOB:

The post holder will provide the direct night care and supervision of the young people accommodated within a Childrens home environment.





MAIN DUTIES:

- To create an environment within the unit that promotes positive respect for children. To work as part of a team who are responsible for meeting the needs identified in their placement plan.
- The post holder is required to ensure all Night Time checks are completed to the stipulated timescales as per the individual young person's Risk Assessment.
- To support the Senior Staff Member when dealing with difficult situations to ensure that any challenging behaviour is dealt with effectively and without injury to child, self and others. Comply with policy and procedures appertaining to security issues.

4	Under direction from the Residential Care Officers contribute to the provision of an environment in which the young people are encouraged to achieve their potential.
5	Be prepared to work flexibly to meet changing needs reflecting the service required.
6	To develop your knowledge and practice by actively participating in mandatory training, through supervision, appraisal, and Night Care Worker meetings.
