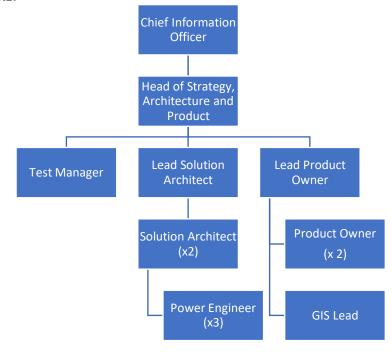
Job Title: Test Manager

### **PURPOSE OF JOB:**

The Test is responsible for defining and leading the council's test strategy, ensuring that all IT solutions meet the highest standards of quality, security, and compliance before deployment. This role is critical in shaping the overall approach to testing, driving automation, and embedding best practices across supplier-led and internal product teams.

The postholder will work closely with stakeholders to define testing requirements and approaches, specifically related to agile product development (CI \ CD pipelines), oversee user acceptance testing (UAT) and parallel running, and ensure continuous improvement in testing methodologies. They will also ensure alignment with the Government Digital and Data Profession (GDAD) framework, compliance with industry regulations, and full integration of key technologies such as Microsoft Fabric, Microsoft Power Platform, and GIS (ESRI ArcGIS).

  - Develop and implement the council's test strategy, ensuring alignment with IT and business objectives.

• Lead the adoption of quality assurance best practices across digital product teams. • Ensure testing frameworks adhere to industry standards and regulatory compliance requirements. 2 **Supplier Assurance and Compliance** • Oversee supplier-led testing activities to ensure compliance with contractual obligations. Conduct assurance reviews of supplier testing processes, ensuring best practices are followed. • Define clear quality metrics and hold suppliers accountable for delivering against them. **User Acceptance Testing (UAT) and Parallel Running** • Lead UAT planning and execution to ensure that digital solutions meet business needs before deployment. Ensure transparent communication of test outcomes to governance boards and senior stakeholders. **Performance and Security Testing** • Ensure performance testing is embedded in the development lifecycle to validate system • Work closely with cyber security teams to test for vulnerabilities and ensure secure-bydesign principles. • Lead testing efforts for resilience, disaster recovery, and failover capabilities. **Governance, Compliance, and Risk Management** • Ensure all testing activities align with the Government Digital and Data (GDAD) framework. • Embed risk-based testing methodologies to prioritise critical business functions. • Maintain comprehensive audit trails for all testing activities, ensuring compliance with regulatory frameworks. **Integration and Data Assurance Testing** • Ensure integration testing validates data flow between core IT systems, including Microsoft Fabric and Power Platform. • Support testing of GIS data accuracy and interoperability within ESRI ArcGIS. • Ensure data processing and reporting systems meet quality and accuracy standards. **Cloud and Infrastructure Testing** • Ensure robust testing strategies for cloud-based and hybrid infrastructure environments. Validate infrastructure changes to prevent service disruptions. • Support cloud migration testing to ensure secure and efficient deployment of services. 10 Usability, Accessibility, and Cross-Platform Testing • Ensure digital products comply with WCAG accessibility standards and usability best • Work with UX teams to validate the user experience across different devices and platforms. • Conduct cross-browser and mobile testing to ensure optimal performance across all
